

This job aid provides step-by-step instructions for using FPMT's lease renewal wizard to renew a lease contract. If you are renewing a lease with an associated receivable lease, refer to the <u>Master Lease and Receivable Lease</u> <u>Renewal</u> job aid.

As of April 2024, FPMT's accounting functionality and integration with the Agency Financial Reporting System (AFRS) have been removed. There is now only one agency editor role, which has access to all wizards.

## Overview

Where do I access the renewal wizard?	<ul> <li>The renewal wizard is accessed via the menu button on the expiring lease contract tile.</li> </ul>
When should I renew a lease?	<ul> <li>Leases should be renewed no later than 30 days after the new lease start date.</li> </ul>
What information do I need to renew a lease?	<ul> <li>A copy of the new lease contract.</li> <li>The expiring lease contract number.         <ul> <li>If you need to locate a lease number, you can run a Lease Contract Inventory Report from the agency tile in FPMT.</li> </ul> </li> <li>If this is a renewal of office space that is in scope for the Six-Year Facilities Plan, populate the tenant improvement one-time cost fields in the lease contract table, if applicable. If actuals are not available, use an estimate and update the system when you have actuals.</li> </ul>
What is the difference between a lease renewal and a lease extension?	<ul> <li>A lease renewal involves a new lease number.</li> <li>A lease extension is an <u>amendment</u> to an existing contract.</li> </ul>
Why should I use the wizard?	<ul> <li>Users can no longer manually edit data in FPMT and must use the wizards to renew lease contracts.</li> <li>The wizard simplifies the renewal process by guiding you through each step and reducing manual activity in the system.</li> <li>The wizard also includes business rules, or validation checks, to prevent incomplete data and common data entry errors.</li> </ul>

Make sure to allow enough time to complete the renewal process in one sitting. If you time out during the
renewal process, you will lose your data.

• You navigate through the wizard by clicking the Next or Previous buttons.



## Launch the Lease Renewal Wizard

Navigate to the expiring lease contract and launch the lease renewal wizard.

- **1. Open** the Data Explorer module.
- 2. Select the Q Search button on the data explorer tool bar.
- 3. Select Filter by and choose Lease Contracts.
- 4. Select Refine by → and choose Lease Number.
- **5.** Enter the lease number for the expiring lease contract.

→If you need to locate the expiring lease contract number, run the Lease Contract Inventory Report available via the menu button on the agency tile.

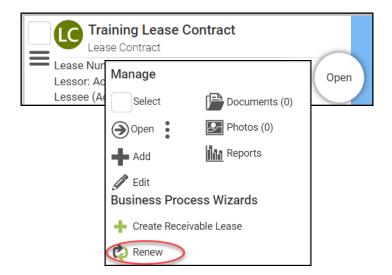

- 8. Select 📿 Renew

→FPMT will open the lease renewal wizard in a new window.

→ The system will automatically populate information from the existing lease. You may update this information if there are changes.





## **Renew the Lease Contract**

- **1.** Enter agency data. Red fields are required.
  - Name
    - →Use the lease number
  - Lease Number
     Lease numbers must be unique; they cannot be used for more than one record.

     →The date the last party signed.
  - Lease Start Date

→ The following fields only apply to office spaces that are in scope for the Six-Year Facilities Plan. If your facility is out of scope, select No.

→If any of these fields are relevant to your location and you do not have actuals, enter an estimate. Do not leave the cost fields blank. When actuals are available, update the record.

→If you select Yes for the red (systemrequired) fields, additional fields become required.

2. Once you have completed the lease contract table, select Next >



-



→If you navigate away from the lease contract form before properly completing the table, you will receive an error message.

 $\rightarrow$  You cannot move forward until the error is fixed.

**Note:** This error will show up in every table if you try to save with missing/incorrect data or try to navigate away before properly completing the table. In addition to this error, you will see a message in pink with more detail.

→In addition to validating that all required fields have been populated, the wizard will also ensure that the lease contract start date is a date prior to the lease contract end date.

## Add a Lease Payment

1. Select Add New Lease Payment

→You cannot save and close the renewal until you add at least one lease payment. If there is no base rent for the facility, enter a lease payment for 0.

- **2.** Enter agency data. Red fields are required.
  - Name

→Use payment type – payment series number (e.g., Base Rent - 1).

- Payment Series Number
   Use sequential numbers for payment series (1, 2, 3, etc.).
- Payment Frequency (dropdown)
- Payment Type (dropdown)
- Payment Amount
- Index Rate

➔Index or rate used to determine payment amounts. Required if payment type is Indexed Payment.

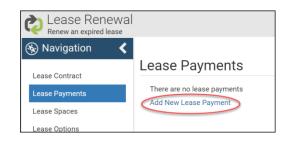

## 3. Select SAVE CHANGES

→The lease payment table features the following validation checks:

- All required fields must be completed.
- Index Rate is required if Payment Type is "Indexed Payment."
- The lease payment start and end dates must fall within the parameters of the lease contract start and end dates.

→The lease payment table cannot be saved until errors are corrected.

→If you navigate away from the lease payment table before saving, you will receive an error.

 $\rightarrow$ Once the lease payment is saved, you can update the information by selecting the details icon or delete the payment by selecting the trash can.

→Repeat this process if there is more than one lease payment series. All payments can have an Active status.

→You must enter all lease payment series for the contract, even if the lease is being entered into FPMT retroactively.

→Once you are done adding payments, select way to add a Space.

## Add a Space

The renewal wizard was recently updated and now requires users to create a new space when renewing a lease.

- 1. Select Add New Space
- **2.** Enter agency data. Red fields are required.

→ Select the information ⑦ icon for additional guidance about fields.

- Name
  - →Use the Space ID
- Space ID

→ UFI-Lease Number-Space Number (e.g., A27122-SRL 24-0001-1)

→Use sequential space numbers if there is more than one space (e.g., 1, 2, 3)

Square Feet

→The sum of all space square feet cannot exceed the total square feet in the lease contract.

- →Refer to the <u>Property Class &</u> <u>Space Type Categories</u> job aid for additional information.

→If Available Space is marked Yes, you must populate the Annual Full Service Rate per Square Foot and Available Occupancy Date fields.

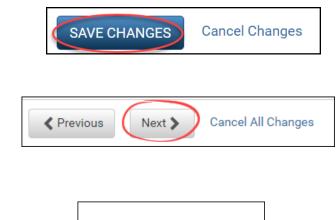

#### Errors

• The square footage of all spaces associated with a lease contract cannot exceed the lease contract square feet. The lease contract square feet is currently 19,440 and the total associated space square feet is 19 447.





→If this leased facility is in scope for the Six-Year Facilities Plan, you must populate the following additional fields:

- Number of Offices
- Number of Cubicles .
- Number of Touchdown Spaces →Refer to any <u>unassigned</u> workspace (office, cube, bench etc.) that could be used for hoteling as a touchdown space.

→ Select the information ? icon for definitions.

→OFM will populate user count fields from HRMS data via import.

 $\rightarrow$  If you're updating the square footage, make sure the total space square feet matches the square feet in the lease contract table.

→You will receive an error message when you click Next if the space square feet exceeds the lease contract square

3. Select SAVE CHANGES

→ If you need to add a Lease Option, select Next >

→ If you **do not** need to add a lease option, select Next >> four times to skip ahead to Data Review.

amendment, refer to the <u>amendments</u> job aid for details on required table updates by amendment type.

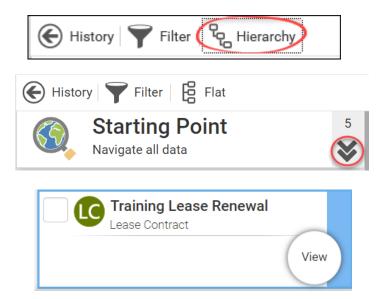
## Data Review

- **1. Select** the <sup>R</sup> Hierarchy button to change to the <sup>R</sup> Flat view. You can now see all the tables you have added or edited as part of the renewal process.
- Select the arrows in the Starting Point tile to expand all of the tiles below.
- **3. Select** View on each tile to see the data you have entered for the renewal.
- **4. Review** the data for your lease renewal.

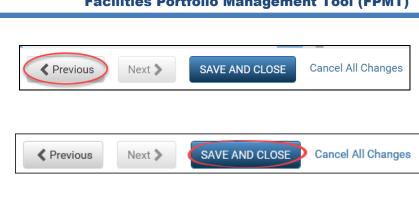

➔To edit your data, use the Previous button to navigate back to an earlier screen.



- Select SAVE AND CLOSE to complete your renewal.
- 6. You will see a warning that lets you know you can't go back into the wizard after saving and closing. If you don't need to make any additional edits, select YES.

→When you complete the renewal, the window will automatically close. FPMT will still be open in the original window. You will need to refresh your screen in order to see your changes.

 $\rightarrow$  Continue to the next step below to upload a copy of the new contract.

## **Upload Copy of New Contract**

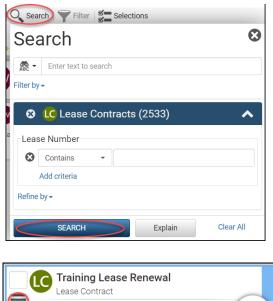
**1.** Select the <u>Search</u> search button on the data explorer tool bar.

- **2. Remove** the old lease number and enter the new one.
- 3. Select SEARCH
- 4. Select the menu button on the new lease contract tile.
- 5. Select Documents

→The document manager will open in a new window.

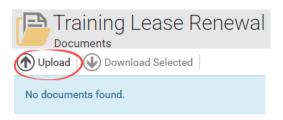
