ORDINANCE NO. 739

AN ORDINANCE DEFINING AND FIXING THE CORPORATE CITY LIMITS EXCLUDING AREA EXCLUDED BY ELECTION.

WHEREAS, a reduction of the city limits was placed on the ballot for election process pursuant to RCW 35A.16; and,

WHEREAS, the election was held November 4, 1998 and the votes have been canvassed as provided in RCW 29.13.040, which shows that 567 votes have been counted and that 373 of those votes were in favor of excluding certain property from the city, which is 65.7% of the total vote; and,

WHEREAS, RCW 35A.16.040 requires the City Council to adopt an ordinance defining and affixing the corporate limits excluding the area determined by the election;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RIDGEFIELD, WASHINGTON, DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. The city limits of the City of Ridgefield shall be and are hereby defined and fixed as described in Exhibit "A" attached hereto and by reference made a part hereof, which legal description excludes the area removed by virtue of the election held on November 4, 1998.

Section 2. Territory excluded through the election process is described by metes and bounds in Exhibit "B" attached hereto and by reference made a part hereof and is no longer a part of the City of Ridgefield, Washington.



Section 3. The Clerk and Planning Director are directed to make the appropriate notification of reduction of city limits to the Washington State Boundary Review Board of Clark County and record and file this Ordinance and a map with the Clark County Auditor.

Section 4. This Ordinance shall become effective thirty (30) days after adoption and publication pursuant to law.



Commencing at a point on the East bank of Lake River on the South line of Section 19, Township 4 North, Range 1 East of the Willamette Meridian;

Thence Easterly along the center line of said Section 29, to a point that is 643.50 feet East, more or less, of the Northwest corner of the Southeast quarter of Section 29 at the intersection with the West line of that tract of land conveyed to Joseph T. Wells, by deed recorded in Book 60, at page 251, Deed Records of Clark County;

Thence South $0^{\circ}58'40''$ West along the West line of said Wells tract to a point that is 60 feet North of the South line of the Northwest quarter of the Southeast quarter of said Section 29;

Thence South $89^{\circ}22'53''$ East to the Easterly right of way line of County Road No. 25, also known as N.W. Royle Road;

Thence Southwesterly along the East right of way line of said N.W. Royle Road to the Southwesterly right of way line of N.W. Hillhurst Road, also known as State Highway 1-T, then to a point on said right of way line that is due North of a Northerly extension of the East line of a Hendrickson tract described in Auditor's File No. 8807080086;

Thence South along the Northerly extension of said East line of said Hendrickson tract to the Northeast corner of said Hendrickson tract, which corner is 40 feet West of the Southeast corner of the Southwest quarter of Section 29, Township 4 North, Range 1 East of the Willamette Meridian;

Thence West along the South line of said Section 29 to the Southwest corner of said Section 29 and continuing West along the South line of said Section 30, Township 4 North, Range 1 East of the Willamette Meridian, to the Southwest corner of said Section 30;

Thence continuing West along the South line of Section 25, Township 4 North, Range 1 West of the Willamette Meridian, to the East bank of Lake River;


Thence Northeasterly along the East bank of said Lake River to the South line of said Section 19 and the point of beginning.

T4N, R1E, WM WHICH ARE EXCLUDED FROM
THE CITY OF RIDGEFIELD**

That portion of Section 31, Township 4 North, Range 1 East, Willamette Meridian, more particularly described as follows:

Commencing at the Northeast corner of the Northwest quarter of Section 31; thence South $0^{\circ}51'43''$ West 2684.67 feet along the East line of the Northwest quarter of said Section 31 to the Southeast corner of said Northwest quarter; thence along the South line of said Northwest quarter North $88^{\circ}14'37''$ West to the Western edge of the existing city limits which is also the same point as the Southwest corner of the tract formerly known as the "Souther Tract" found in AFN 8906050178; thence Northerly along said boundary line of the city limits which is also the West line of the described Souther Tract to the North line of the Northwest quarter of said Section 31; thence East along the North line of said Northwest quarter of said Section 31 to the point of beginning.
