



ORDINANCE NO. 5059

AN ORDINANCE of the City Council of the City of Bremerton, Washington, amending Ordinance No. 5053 to extend the effective date of the annexation of SKIA North from October 1, 2008 to November 15, 2008 if Boundary Review Board jurisdiction is not invoked.

WHEREAS, on July 30, 2008, the City Council passed Ordinance No. 5053 annexing certain property known as SKIA North into the City of Bremerton; and

WHEREAS, the City Council established the effective date of the annexation as October 1, 2008 or if Boundary Review Board jurisdiction is invoked, on the first day of the of the full month immediately following the expiration of the Boundary Review Board's review; and

WHEREAS, the Boundary Review Board's initial 45 day review period will expire on or about October 8, 2008, after the stated effective date of the annexation set forth in Ordinance No. 5053; and

WHEREAS, the City Council desires to extend the effective date of the annexation to November 15, 2008 if Boundary Review Board jurisdiction is not invoked during the initial review period; NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF BREMERTON, WASHINGTON,
DOES HEREBY RESOLVE AS FOLLOWS:

SECTION 1. Section 6 of Ordinance No. 5053 is hereby amended in its entirety to read as follows:

This annexation will become effective November 15, 2008 if Boundary Review Board jurisdiction is not invoked. If Boundary Review Board jurisdiction is invoked pursuant to RCW 36.93.100(4), then this annexation will become effective on the first day of the second month immediately following the expiration of the Boundary Review Board's review.

SECTION 2. *Severability.* If any one or more sections, subsections, or sentences of this Resolution are held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portion of this Resolution and the same shall remain in full force and effect.

SECTION 3. Effective Date. This Ordinance shall take effect and be in force 10 days after the date of publication.


