ORDINANCE NO. 625

BEING AN ORDINANCE AMENDING ORDINANCE NO. 521 OF THE CITY OF CASHMERE BEING AN ORDINANCE ANNEXING TO THE CITY OF CASHMERE TERRITORY AND PREMISES CONTIGUOUS THERETO.

BE IT ORDAINED by the City Council of the City of Cashmere as follows:

Section 1: That Ordinance No. 521 of the City of Cashmere annexed certain premises to the City of Cashmere. That there is an error in the legal description of the premises and that error shall be cured by amending the legal description.

Section 2: That the legal description set forth in Section 1 of Ordinance No. 521 of the City of Cashmere is hereby amended to read as follows:

A portion of Lot 5, Cashmere Park Addition in the northeast quarter of the southeast quarter of Section 5, Township 23 North, Range 19, East of the Willamette Meridian, Chelan County, Washington, described as follows:

Commencing at a marked stone set at the center of said Section 5, Township 23 North, Range 19, East of the Willamette Meridian; thence south $86^{\circ}03\frac{1}{2}'$ east along the center line of Pioneer Avenue and the east-west center line of Section 5, for 1295.8 feet to an iron pin at the northwest corner of the northeast quarter of the southeast quarter of said Section 5; thence south $01^{\circ}18'$ east along the west line of said subdivision for 805.36 feet; thence south $88^{\circ}03\frac{1}{2}'$ east for 330.0 feet to the true point of beginning of this description; thence continuing south $88^{\circ}13\frac{1}{2}'$ east for 308.05 feet to the westerly right of way line of the county road; thence south $2^{\circ}02'$ east along said right of way line for 66.0 feet; thence north $88^{\circ}13\frac{1}{2}'$ west for 309.25 feet; thence north $01^{\circ}18'$ west for 66.0 feet to the true point of beginning, EXCEPTING roads.

SUBJECT TO matters relating to water and water rights and rights of way for necessary conduits and facilities for distribution of water, if any, and right of entry for repair and maintenance.

Section 3: This ordinance shall be in full force and effect when it shall have been passed by the City Council of the City of Cashmere, signed by the Mayor and attested by the City Clerk and from and after its publication in the Cashmere Record, the official newspaper of said City and after the necessary period of time has elapsed as provided by law.
