

ORDINANCE NO. 1215AN ORDINANCE OF THE CITY OF ARLINGTON, WASHINGTON
AMENDING ORDINANCE 1198 WHICH
ANNEXED THE SMOKEY POINT ANNEXATION AREA

WHEREAS, the City of Arlington, Washington has the authority to enact laws to promote the health, safety and welfare of its citizens as a way of controlling the use and development of property within its jurisdiction; and

WHEREAS, the City Council on August 2, 1999 adopted Ordinance No. 1198 which annexed the Smokey Point area to the City of Arlington, but said ordinance contained an inaccurate legal description concerning the rights of way pertaining to Interstate 5; and

WHEREAS, the City Council deems adoption of this ordinance to be in the best interests of the citizens;

NOW, THEREFORE, the City Council of the City of Arlington do hereby ordain as follows:

Section 1. Exhibit "A" of Arlington Ordinance No. 1198 shall be and hereby is amended to read as follows:

Legal Description of The Area To Be Annexed: All that property located within Sections 20, 21, 28, and 29, Twp 31 North, Range 5E, W.M., more particularly described as follows: Commencing at the SE corner of the SW quarter of Section 21, Township 31 N, Range 5 E, of the Willamette Meridian, County of Snohomish, State of Washington, said point being the SW corner of Arlington City Limits and the True Point of Beginning. Thence, Northerly, along the E line of the aforementioned quarter section, to the SE corner of the NW quarter of said Section 21; thence Westerly, along the S line of the NW quarter, to the SW corner of the E ½ of the W ½ of the said NW quarter, thence Northerly, along the W boundary of said E ½ to the N line of said section; thence Westerly, along the N line of said section to the NW corner, thereof; thence continuing Westerly along N line of Section 20, to the centerline of Primary State Highway No. 1 (Interstate 5); thence Southerly; along the centerline of Primary State Highway No. 1, to the N line of the NE quarter of Section 29; thence continuing Southerly along said E margin to the South line of the NE

quarter of Section 29; thence Easterly along the S line of the NE quarter of Section 29 to the SW corner of the NW quarter of Section 28; thence Easterly along the S line of the NW quarter of Section 28 to the SE corner of the NW quarter of Section 28; thence Northerly along the East line of the NW quarter of Section 28 to the True Point of Beginning, together with adjacent Rights-of-way except Interstate 5.

Section 2. Severability. If any provision, section, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


Section 3. Effective Date. This annexation shall be effective five days from its passage and publication of this ordinance as provided by law.




