SUBJECT: ALLOTMENT REDUCTION FOR CENTRAL SERVICE AGENCY

**EXPENDITURES** 

Section 718 of 3ESSB 5034 (Chapter 4, Laws of 2013, 2<sup>nd</sup> Special Session) directs the Office of Financial Management to reduce General Fund-State allotments for all agencies by \$5.0 million for the 2013-15 biennium to "reflect (1) available fund balance in dedicated revolving funds used for central services to state agencies and (2) more efficient delivery of consolidated central services to state agencies."

## OFM calculated the allotment reduction as follows:

- To comply with federal cost allocation rules, any central service agency billing reduction must be applied to all fund sources, not just General Fund-State. The \$5 million GF-S reduction therefore translates to about a \$12.1 million total funds reduction for all central service provider agencies.
- In most cases, central service provider agencies (including separately elected officials) were asked to implement temporary billing reductions or rate holidays using any available fund balance, including reducing recommended working capital reserves.
- To the extent possible, central service provider agencies will use fund balance to support current expenditures without reducing services to agencies.
- OFM applied the fund splits used in the central services model to estimate the General Fund-State reduction for each agency for all central service billings.

Below is a summary of how central service provider agencies plan to modify their billings and rates over the remainder of the 2013-15 biennium to meet the GF-S savings target:

- The Secretary of State will use fund balance to reduce billings over the remainder of the biennium beginning with the fourth quarter of FY 2014.
- The State Auditor will use fund balance to reduce billings for selected agencies over the remainder of the biennium.
- The Attorney General will use fund balance to reduce billings over the remainder of the biennium beginning with the April 2014 bill.

- The Office of Administrative Hearings will work with affected client agencies to manage the hearing workload to reduce OAH charges while maintaining timeliness and compliance with federal and state requirements.
- Consolidated Technology Services will reduce the charges for security infrastructure in FY 2014.
- The Department of Enterprise Services will reduce agency billings over the remainder of the biennium.
- The Office of Financial Management will use fund balance to:
  - o Not bill for the personnel services fee for the fourth quarter of FY 2014 and issue rebates for previous FY 2014 charges.
  - o Issue rebates for the Labor Relations Division charge for previous FY 2014 charges (including any fourth quarter FY 2014 charges already paid).
  - o Reduce charges for the Office of the Chief Information Officer over the remainder of the biennium beginning in May 2014.

Attached is an agency breakdown of allotment reductions to fulfill the requirements of Section 718. Please submit an allotment packet by May 15, 2014, using a packet purpose type of "Operating Legislative Allotment Reductions" to place your reduction in reserve.
