Highlights of findings:

The rate of increase in insurance premiums declined statewide between pre- and post-ACA implantation.

The unemployment rate declined statewide from January 2010 to December 2016.

The 3rd, 4th, 5th and 6th had higher proportions of individuals enrolling in QHP and Medicaid through the Exchange than was seen statewide.


The 2nd, 3rd, 8th and 9th had higher proportions of individuals enrolling into QHP than statewide,

The 3rd, 4th, 5th, 6th and 10th had higher proportions of individuals enrolling in Medicaid through the expansion program than statewide.

The 1st, 2nd, 4th, 5th, 6th, 8th and 9th saw marked decreases in the number of persons reporting having to forego needed care. Decreases were also seen in the remaining districts, but those leveled off in 2015.

The amount of charity care provided by hospitals in each congressional district markedly declined in all districts except the 8th where it leveled off in 2015.

Average annual premium increases have dropped since the ACA passed and became law




Unemployment rates have fallen since 2010 and appear to be continuing downwards












Medicaid and Exchange (QHP) enrollment in 2016



Hospital charity care as a percent of adjusted revenues, 2012-15








Medicaid and Exchange (QHP) enrollment in 2016

Hospital charity care as a percent of adjusted revenues, 2012-15











Hospital charity care as a percent of adjusted revenues, 2012-15









Hospital charity care as a percent of adjusted revenues, 2012-15









Hospital charity care as a percent of adjusted revenues, 2012-15















Hospital charity care as a percent of adjusted revenues, 2012-15














