SUBJECT: CHAPTER 10 - TRAVEL; CHAPTER 12 - TRANSPORTATION;

CHAPTER 25 - PAYROLL; CHAPTER 50 - FEDERAL COMPLIANCE;

AND CHAPTER 75 - UNIFORM CHART OF ACCOUNTS

We have revised several chapters of the *State Administrative and Accounting Manual* (SAAM). This change is effective July 1, 2007.

Key changes to the policies include:

<u>CHAPTER 10: TRAVEL</u> (http://www.ofm.wa.gov/policy/10.htm) (Section 10.90)

 Revised privately owned aircraft mileage reimbursement calculation from statute mile to nautical mile.

<u>CHAPTER 12: TRANSPORTATION</u> (http://www.ofm.wa.gov/policy/12.htm) (Sections 12.10, 12.20, and 12.30)

- Emphasized agency responsibility for managing and controlling the use of state-owned vehicles.
- Clarified use of state-owned vehicles for emergency ride home programs.
- Added Subsection 12.20.70 for *Good to Go!* transponders.

<u>CHAPTER 25: PAYROLL</u> (http://www.ofm.wa.gov/policy/25.htm) (Sections 25.40, 25.70, and 25.80)

- Adjusted fringe benefit rate for shared leave calculations.
- Added Subsection 25.40.15 for sick leave pools.
- Increased limits of payment to relatives of deceased employees to \$11,250.
- Revised policy for salary overpayments. Clarified recoveries for represented and nonrepresented employees.

<u>CHAPTER 50: FEDERAL COMPLIANCE</u> (http://www.ofm.wa.gov/policy/50.htm) (Subsection 50.40.30)

• Maintains the threshold for programs subject to CMIA regulations at \$35 million or more.

<u>CHAPTER 75: UNIFORM CHART OF ACCOUNTS</u> (http://www.ofm.wa.gov/policy/75.htm) (Sections 75.20, 75.30, 75.40, 75.70, and 75.80)

- Added new agency: 4780.
- Deleted agency: 3450.
- Changed name of agency 4670 to Recreation and Conservation Funding Board (previously Interagency Committee for Outdoor Recreation).
- Added new accounts: 09C, 09G, 11K, 11M, 11N, 11P, 11R, 11T, 11W, 12A, 12B, 12C, 12E, 12F, 12G, 12H, 12J, 12K. 12L, 12M, 12N, 12P, 12R, 12T, 12V, 12W, 14A, 14B, 14C, 14E, 14F, 14G, 14H, 14K, and 442.
- Changed the name of accounts 10B, 10L, and 755.
- Deleted account 560.
- Changed fund type and rollup fund of accounts 439, 755, and 793.
- Changed administering agency for accounts 113, 247, and 291.
- Added new subobject code: EH Rentals and Leases Furnishings, Equipment, and Software.
- Revised the description for subobject codes: CA Management and Organizational Services, CD Computer and Information Services, CE Social Research Services, CJ Employee Training Services, ED Rentals and Leases – Land and Buildings, and GD Other Travel Expenses.
- Revised the description for Object T Intra-Agency Reimbursements.
- Changed the name of revenue source codes: 0136, 0143, 0191, 0209, and 0486.
- Added new revenue source codes: 04TH Timber Harvest Distributions, 0690 Special Litigation Transfers, and 0634 Streamlined Sales and Use Tax Mitigation Transfer.
- Deleted unused revenue source codes: 0213, 0228, 0230, 0247, 0259, 0267, 0269, 0280, 0282, 0284, and 0293.
- Added descriptions for revenue source codes: 0100 Taxes, 0200 Licenses, Permits, and Fees, and 0300 Federal Revenue.
