

ORDINANCE NO. 4539

**An Ordinance of the City Council of the City of Ellensburg, Washington amending Section 7 of Ordinance No. 4528 to establish April 1, 2009 as the effective date for the annexation of certain territory known as the Wollen Annexation to the City of Ellensburg, Washington.**

WHEREAS, a petition came on for hearing before the City Council at its regular Council meeting on October 20, 2008, and the Council deemed it wise and expedient that said territory known as the Wollen Annexation should become a part of the City of Ellensburg, Washington; and

WHEREAS, the following described territory known as the Wollen Annexation was annexed to and made a part of the City of Ellensburg and zoned Residential Suburban:

Map Parcel No. 17-18-01068-0001 Approximately 2.459

Lot 1 of WILLIAM'S SHORT PLAT, as described and/or delineated on Kittitas County Short Plat No. 79-07, recorded July 6, 1979 under Auditor's File No. 433926 and filed in Volume "A" of Short Plats, page 1, records of Kittitas County, State of Washington, being a portion of Block 24, SUNNYSIDE ADDITION TO THE CITY OF ELLENSBURG, as per plat thereof recorded in Volume I of Plats, page 25, records of said county.

TOGETHER WITH that portion Cedar Street as conveyed by the City of Ellensburg under Quit Claim Deed recorded May 19, 1999 under Auditors File No. 199905190014 AND that portion of Seattle Avenue from center line of vacated Cedar Street to the east line of Willow Street.

and

WHEREAS, in Section 7 of Ordinance 4528 the City Council determined the effective date of the annexation would be fifteen (15) days after the certified date of the expiration of the 45-day comment period or the Chair of the Board's written statement declaring review is not necessary or the effective date of the resolution of the Washington State Boundary Review Board for Kittitas County, whichever date first occurs; and

WHEREAS, a certified copy of the Minutes of the October 20, 2008 City Council Meeting and other documentation as required was filed on December 4<sup>th</sup> 2008 with the Washington State Boundary Review Board for Kittitas County; and

WHEREAS, in January 2009 the Board of Kittitas County Commissioners disbanded the Washington State Boundary Review Board for Kittitas County,

NOW THEREFORE,

THE CITY COUNCIL OF THE CITY OF ELLENSBURG, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. All portions of Ordinance No. 4528 annexing territory known as the Wollen Annexation shall remain in full force and effect except as specifically amended herein.

Section 2. Section 7 of Ordinance No. 4528 is hereby amended to establish April 1, 2009 as the effective date of the Wollen Annexation.

Section 3. This ordinance shall take effect and be in full force five (5) days after its passage, approval and publication.


