

Ordinance No. 6418

AN ORDINANCE authorizing a corporate boundary line adjustment between the City of Olympia and Thurston County of that segment of Miller Avenue NE, lying outside the corporate limits of the City of Olympia, between Fairview Street and Friendly Grove Road.

WHEREAS, the boundary line between the City of Olympia and Thurston County in the area of Miller Avenue NE is located on the south side of the portion of Miller Avenue NE lying outside the corporate limits of the City of Olympia, between Fairview Street and Friendly Grove Road as depicted on the attached and incorporated map; and

WHEREAS, Thurston County's jurisdiction over a segment of Miller Avenue NE has created complications relating to the City of Olympia's construction of a sidewalk along the north right-of-way of Miller Avenue NE; and

WHEREAS, pursuant to RCW 35A.21.210, the City of Olympia and Thurston County have agreed to revise the corporate boundary of the City of Olympia so as to fully include that segment of Miller Avenue NE as described herein such that it will be located within the boundaries of the City of Olympia; and

WHEREAS, such revision of the corporate boundary between the City of Olympia and Thurston County would be of benefit both to the City of Olympia and its citizens and to Thurston County and its citizens; and

WHEREAS, on July 24, 2006, Thurston County passed Ordinance No.13621 approving the corporate boundary revision described herein; NOW, THEREFORE

THE OLYMPIA CITY COUNCIL ORDAINS AS FOLLOWS:

**Section 1. Corporate Boundary Line Revision.** The corporate boundary line between the City of Olympia and Thurston County is hereby revised to fully include in the corporate limits of the City of Olympia that segment of Miller Avenue NE lying between Fairview Street and Friendly Grove Road as described below and as depicted in Exhibit "A" attached hereto and incorporated herein by reference:

Parcels: 09400001001 49603300001 49603500200  
49603500002

That part of the South Half of Section 12, Township 18 North, Range 2 West, W.M. described as follows:

All of the public right-of-way of Miller Avenue lying between the West line of said Half and the East right-of-way line Friendly Grove Road as it existed on May 1, 2006 and thereafter as modifications may occur to said right-of-way; EXCEPTING THEREFROM, that portion lying within the existing City Of Olympia as annexed under City Of Olympia Ordinance Number 3476.

**Section 2. Ratification.** Any act consistent with the authority and prior to the effective date of this ordinance is hereby ratified and affirmed.



**Section 3. Severability.** The provisions of this ordinance are declared separate and severable. If any provision of this ordinance or its application to any person or circumstances is held invalid, the remainder of this ordinance or application of the provision to other persons or circumstances, shall be unaffected.




Exhibit A to Ordinance
