ORDINANCE NO. 1048

IN THE MATTER OF AN ANNEXATION OF ROADS WITHIN THE CITY LIMITS OF COLLEGE PLACE

WHEREAS, The City of College Place proposes to annex rights-of-way lying partially inside and partially outside the city limits, and

WHEREAS, Pursuant to RCW 35A.21.210 cities may adjust the boundaries of a city to fully include or exclude that segment of the public street, road or highway from the corporate limits of the city subject to the approval of the City and the County, and

WHEREAS, Such a boundary revision is not subject to potential review by a boundary review board, and

WHEREAS, the sections of NE Lambert, NE Spitzenburg, and NE Della as described herein are located fully within the corporate boundaries of the City of College Place, and

WHEREAS, the Public Works Committee of the City of College Place has reviewed and recommended approval of the annexation, and

WHEREAS, the annexation of these roads provides jurisdictional clarity for public safety.

NOW THEREFORE, the City Council of the City of College Place do ordain as follows:

Section 1: The property illustrated in the attached annexation boundary map (Exhibit A), which is described as follows, is hereby annexed to the City of College Place:

**NE LAMBERT AVENUE, NE SPITZENBURG STREET and NE DELLA AVENUE ANNEXATION DESCRIPTION**

Those Portions of three Streets; **NE Lambert Avenue, NE Spitzenburg Street, and NE Della Avenue**, situated in the Southeast quarter of Section 25, Township 7 North, Range 35 East, W.M., Walla Walla County, Washington, described as follows;

1. That portion of **NE Lambert Avenue** per the 40.00 foot wide dedication thereof on the Blalock Orchards District 1 plat, as filed August 6, 1909, in volume "D" of plats at page 44, records of said County and State, lying between the official corporate limits of the City of College Place established by Annexation Ordinance No. 453 on the South and Annexation Ordinance No. 510 on the North.
2. That portion of **NE Spitzenburg Street** per the 40.00 foot wide dedication thereof on the Blalock Orchards District 1 plat, as filed August 6, 1909, in volume "D" of plats at page 44, records of said County and State, lying between the official corporate limits of the

City of College Place established by Annexation Ordinance No. 478 on the East and Annexation Ordinance No. 949 on the West.

3. All of **NE Della Avenue** per the 60.00 foot wide dedication thereof on the "Vogt's Replat" as filed December 23, 1955, in volume "F" of plats at page 22, records of said County and State, lying North of the official corporate limits of the City of College Place established by Annexation Ordinance No. 476.

Section 2. Notice is hereby given by this Ordinance to the firm responsible for the collection of garbage that they may apply and receive an extension of their present garbage franchise for a period of 7 years as provided in RCW 35.13.280. Said grant is herein subject to said person, firm, or corporation providing adequate service to said annexed territory at a reasonable price.

Section 3. This ordinance shall become effective five days after passage, approval and publication.
