## **ORDINANCE NO. 2009-874**

AN ORDINANCE OF THE CITY OF DEER PARK, WASHINGTON, ANNEXING CERTAIN REAL PROPERTY OWNED BY THE CITY AND LOCATED NORTH OF THE AIRPORT AND CONSISTING OF APPROXIMATELY 313.9 ACRES AND AS THE AREA IS LEGALLY DESCRIBED IN EXHIBIT "A" AND DEPICTED ON THE MAP, EXHIBIT "B", DESIGNATING THE ZONING OF THE ANNEXATION AREA; APPROVING THIS TITLE AS THE SUMMARY OF THIS ORDINANCE; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, following application by the City of Deer Park to amend the existing Urban Growth Area for the City ("UGA") to add approximately 313.9 acres owned by the City to be used for municipal purposes, Spokane County processed and the Spokane County Commissioners unanimously approved the proposed UGA Boundary Revision by the passage of County Resolution 8-1105 on December `16, 2008; and

**WHEREAS**, the area annexed to the City, pursuant to this Ordinance, is now inside the UGA; and

**WHEREAS,** RCW 35A.14.300 authorizes the City Council to annex property owned by the City and used for municipal purposes at any time by a majority vote of the City Council; and

**WHEREAS,** RCW 36.93.090(1)(a) provides that this change of boundary of the City is exempt from the County Boundary Review Board review requirements; and

**WHEREAS**, the City Council finds that it is in the best interest of the health, safety, and general welfare of the citizens of the City that this Ordinance be approved and the area proposed for annexation be annexed to the City; NOW THEREFORE.

THE CITY COUNCIL OF THE CITY OF DEER PARK, WASHINGTON DO ORDAIN AS FOLLOWS:

**Section 1.** The area consisting of City-owned property that is within the UGA and contiguous and adjacent to the present corporate limits of the City of Deer Park and generally located to the north of the City Airport and legally described in Exhibit "A" attached to this Ordinance and depicted on the map on Exhibit "B" attached to this Ordinance (hereinafter the "annexation area"), should be and hereby is annexed to and made a part of the City of Deer Park.

**Section 2.** Zoning of the annexation area described in Section 1 of this Ordinance shall be as depicted in the official pre-annexation zoning map of the City. The City Director of Community Services is directed to insert the appropriate zoning of the annexation area on the official zoning map of the City when this Ordinance becomes effective.

**Section 3.** This Ordinance shall be effective and the annexation area shall become a part of the City of Deer Park, Washington, five (5) days following the date of passage of this Ordinance and publication of a Summary of the Ordinance consisting of the title of this Ordinance.
