AN ORDINANCE ANNEXING PROPERTY COMMONLY KNOWN AS THE SPARKS II ANNEXATION TO THE CITY OF MOSES LAKE, WASHINGTON, AND INCORPORATING THE SAME WITHIN THE CORPORATE LIMITS OF THE CITY OF MOSES LAKE

THE CITY COUNCIL OF THE CITY OF MOSES LAKE, WASHINGTON DO ORDAIN AS FOLLOWS:

<u>Section 1</u>. The following described real estate, as shown on the attached map marked Exhibit A which by this reference is incorporated within this ordinance, situated in Grant County is hereby annexed to and incorporated in the City of Moses Lake:

<u>Section 2.</u> All property within the territory annexed shall hereinafter be assessed and taxed at the same rate and on the same basis as other property within the city.

<u>Section 3.</u> The area annexed will be zoned C-2, General Commercial and Business.

<u>Section 4</u>. That a copy of this ordinance shall be filed with the Board of County Commissioners of Grant County, Washington.

<u>Section 5</u>. This ordinance shall take effect and be in force five (5) days after its passage and publication of its summary as provided by law.
