



**TOWN OF WILBUR  
ORDINANCE NO. 491**

An ordinance of the Town of Wilbur, Washington annexing certain legally described property into the Town of Wilbur for municipal purposes; and providing for the effective date thereof.

WHEREAS, the Town of Wilbur owns certain property outside the limits of the Town, more specifically described in Section 1 below hereto; and

WHEREAS, the Town is constructing a sewage treatment facility on said land; and

WHEREAS, pursuant to RCW Chapter 35.27, the construction, maintenance and operation of said sewage treatment facility is a municipal purpose; and

WHEREAS, the Town Council has determined that annexing said property would be in the best interest of the Town and its citizens; now therefore

**THE TOWN COUNCIL OF THE TOWN OF WILBUR DO ORDAIN AS FOLLOWS:**

**SECTION 1.** The territory which is legally described as follows:

THE SOUTH  $\frac{1}{2}$  OF THE NORTHEAST  $\frac{1}{4}$  OF SECTION 12  
TOWNSHIP 26 NORTH, RANGE 32 E.W.M., lying in the County of  
Lincoln, State of Washington  
should be and hereby is annexed for municipal purposes to and made a part of the Town of Wilbur, Washington.

**SECTION 2.** Zoning of the annexation area described in Section 1 of this Ordinance shall be Industrial.

**SECTION 3.** The Town Clerk shall cause notice of the annexation of this property to be made to the appropriate offices of the State of Washington and Lincoln County.

SECTION 4. Effective Date. This ordinance shall be in full force and effective five (5) days from and after passage, approval and publication.

AN ORDINANCE of the Town of Wilbur, Washington, passed the Town Council July 1, 2009, annexing the following described property into the Town under the provisions of RCW 35.27:

The South ½ of the Northeast ¼ of Section 12 Township 26 North, Range 32 E.W.M. lying in the County of Lincoln, State of Washington.

Providing zoning in the annexed area shall be Industrial; and providing that the ordinance is effective five (5) days from and after passage, approval and publication.
