**CITY OF CHENEY, WASHINGTON  
ORDINANCE NO. V-66**

**AN ORDINANCE ADOPTING THE ANNEXATION OF  
CERTAIN REAL PROPERTY KNOWN AS THE 50-ACRE  
BETZ PARK, AND PROVIDING FOR THE EFFECTIVE  
DATE THEREOF.**

**WHEREAS**, the City of Cheney is a non-charter code city duly organized under the laws of the State of Washington; and

**WHEREAS**, the City of Cheney is a municipal corporation of the State of Washington, located in Spokane County; and

**WHEREAS**, the following ordinance by the City of Cheney to amend the existing city municipal limits, to add approximately 50 acres owned by the City to be used for municipal purposes; and

**WHEREAS**, the area annexed to the City, pursuant to this ordinance, is within the Urban Growth Area (UGA); and

**WHEREAS**, the property is described in the attached Exhibit "A," is owned by the City and is intended to be used for municipal purposes as a park; and

**WHEREAS**, RCW 35A.14.300 authorizes the City Council to annex property owned by the City and to be used for municipal purposes at any time by a majority vote of the City Council; and

**WHEREAS**, RCW 36.93.090(1)(a) provides that a change of boundary of the City is exempt from the County Boundary Review Board review requirements when the property is contiguous to the municipal limits of the City; and

**WHEREAS**, the City council finds that it is in the best interest of the health, safety, and general welfare of the citizens of the City that this Ordinance be approved and the area proposed for annexation be annexed to the City;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHENEY,  
WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1.**     **Annexation.** The area consisting of City-owned property that is within the UGA and contiguous and adjacent to the present corporate limits of the City of Cheney and generally located north of Betz Road and the Eagle Point Apartment complex, and east of S. Betz Road, and legally described in Exhibit “A” attached to this Ordinance and depicted on the map on Exhibit “B” attached to this Ordinance (hereinafter the “Annexation Area”), is hereby annexed to and made part of the City of Cheney for municipal purposes.

**Section 2.**     **Zoning.** Zoning of the Annexation Area shall be R-1 (Single Family Residential). The 2005 Comprehensive Plan designation of the Annexation Area shall be Public. The 2010-2030 Comprehensive Plan designation of the Annexation Area will be Open Space.

**Section 3.**     **Notice of Annexation.** The proper City officers are hereby directed to provide notice of this annexation to the state Office of Financial Management, as provided by law.

**Section 4.**     **Severability.** If any section, sentence, clause or phrase of this ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

**Section 5.**     **Effective Date.** This Ordinance shall be effective and the annexation area shall become a part of the City of Cheney, Washington, thirty (30) days following the date of passage of this Ordinance and publication of the Ordinance.
