ORDINANCE NO. 476

AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 452, BY CORRECTING THE BOUNDARIES OF THE PROPERTY ANNEXED THEREIN BY OMITTING PORTIONS OF COUNTY ROADS.

THE CITY COUNCIL OF THE CITY OF ARLINGTON, WASHINGTON, DO ORDAIN:

Section 1. Whereas, the description of the Arlington Airport contained Ordinance No. 452, annexing the same, included within the boundaries thereof split portions of county roads and it was not the intention of the City to annex such portions and the inclusion thereof was a ministerial mistake.

Section 2. Section 3 of Ordinance No. 452 be and it hereby is amended to read as follows:

Section 3. The following described tract, in Township 31 North, Range 5 East, W.M., Snohomish County, Washington, being the Arlington Municipal Airport, be and it hereby is annexed to the City of Arlington, Washington;

Beginning at the northeast corner of the west half of the east half of the southeast quarter of Section 15; thence southerly along the east boundary of said west half to the south right-of-way line of that certain county road which is located on the south boundary line of Section 15; thence westerly along the south right-of-way line of that certain county road to the east boundary of the west half of the northwest quarter of the northeast quarter of Section 22; thence southerly along the east boundary of said west half to the north boundary of the southwest quarter of the northeast quarter of Section 22; thence westerly along the north boundary of said southwest quarter to the north-south centerline of Section 22; thence southerly along said north-south centerline to the north right-of-way line of that certain county road which is located upon the south boundary of Section 22; thence westerly along said north right-of-way line of county road to its intersection with the easterly right-of-way line of that certain county road located on the north-south centerline of Section 21; thence northerly along said east right-of-way line to its intersection with the east-west centerline of Section 21; thence westerly along said east-west centerline to the west boundary of the east half of the west half of the northwest quarter of Section 21; thence northerly along the said west boundary of said east half to the south right-of-way line of that certain county road located on the north boundary line of Section 21; thence easterly along said south right-of-way line to its intersection with the east right-of-way line of that certain county road located on the west line of the east half of the southeast quarter of Section 16; thence northerly along the said east right-of-way line of the county road to the east-west centerline of Section 16; thence easterly along the east-west centerline of Sections 16 and 15 to the point of beginning. And the south 170 feet of the north 579 feet (measured along the west line thereof) of the east half of the southeast quarter of the southeast quarter of Section 15 lying westerly of a line drawn 40 feet westerly of and parallel to the west line of the right-of-way of the Northern Pacific Railroad Company.

Section 4. This Ordinance shall take effect on its passage and publication.
