

**ORDINANCE # 2012-730**

**AN ORDINANCE OF THE CITY OF ENTIAT, WASHINGTON, PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY OF THE CITY OF ENTIAT AND CLASSIFYING AND ZONING SAID PROPERTY, SUBJECT TO THE CITY'S ZONING CODE.**

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ENTIAT, WASHINGTON, DOES ORDAIN AS FOLLOWS:

**WHEREAS**, a petition to annex the real property hereinafter described was filed with the City Council of the City of Entiat, signed by owners of not less than 60% of the property according to the assessed valuation for the general taxation of property for which annexation is petitioned, and

**WHEREAS**, the applicable zoning for the annexed property will be mixed tourist residential as designated on the pre-annexation zoning map, and

**WHEREAS**, the City Council of the City of Entiat considered all factors relative to the proposed annexation, and

**WHEREAS**, a review proceeding for said annexation is not required pursuant to RCW 35A.14.220.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ENTIAT DO ORDAIN** as follows:

**SECTION I.** That the following described real property located in Chelan County, Washington, contiguous to the City of Entiat, to-wit:

See Exhibit "A" attached hereto and incorporated herein by reference as if fully set forth;

and each and every part thereof be and the same is hereby annexed to the City of Entiat, State of Washington; and that the corporate limits of the City of Entiat be and they are hereby extended so as to include the property and territory hereinbefore fully described. That said property be


Legal for the Upper 40 Acres to be Annexed.

The South half of the Northwest Quarter of the Southwest Quarter; and the North half of the Southwest Quarter of the Southwest Quarter of Section 8, Township 25 North, Range 21, East, W.M., Chelan County, Washington.

Legal for the Lower 20 Acres within the City of Entiat.

The South half of the Southwest Quarter of the Southwest Quarter of Section 8, Township 25 North, Range 21, East, W.M., Chelan County, Washington.


**SECTION II.** That the property described in Section I hereof be and the same is hereby classified and zoned as mixed tourist residential. All such zoning and classification being subject to the Zoning Code of the City of Entiat.

**SECTION III.** The Comprehensive Plan be and it is hereby amended to incorporate the provisions of this Ordinance.

**SECTION IV.** This Ordinance shall take effect from and after its passage five (5) days after publication of such Ordinance once in *The Lake Chelan Mirror*, the same being the official newspaper of the City of Entiat, and the Clerk is hereby directed to cause the same to be so publicized.
