

CORRECTED ORDINANCE NO. 535

AN ORDINANCE OF THE CITY OF NAPAVINE, WASHINGTON, PROVIDING FOR THE ANNEXATION OF THE FOLLOWING DESCRIBED UNINCORPORATED AREA SITUATE IN THE COUNTY OF LEWIS, STATE OF WASHINGTON:

That portion of the South Half of the Northwest Quarter of Section 35, Township 13 North, Range 2 West, W.M., Lewis County, Washington, more particularly described as follows: BEGINNING at the Northeast Comer of said subdivision; thence South along the East line of said subdivision to the Northerly margin of the abandoned Newaukum Valley Railroad Right of Way; thence Westerly along said Northerly margin to the Southwesterly right of way line of Koontz Road; thence Northwesterly along said right of way line to the North line of said subdivision; thence East along said North line to the Northeast Comer of said subdivision and the Point of Beginning. WHEREAS, notice of said hearing has been published and posted as required by law;

WHEREAS, the County has approved the petition and descriptions of the land to be annexed as required by law; now, therefore,

THE CITY COUNCIL OF THE CITY OF NAPAVINE, WASHINGTON, DO ORDAIN AS FOLLOWS:

<u>Section 1</u>. The following described unincorporated real property situate in the county of Lewis, state of Washington:

That portion of the South Half of the Northwest Quarter of Section 35, Township 13 North, Range 2 West, W.M., Lewis County, Washington, more particularly described as follows:

BEGINNING at the Northeast Corner of said subdivision; thence South along the East line of said subdivision to the Northerly margin of the abandoned Newaukum Valley Railroad Right of Way; thence Westerly along said Northerly margin to the Southwesterly right of way line of Koontz Road; thence Northwesterly along said right of way line to the North line of said subdivision; thence East along said North

line to the Northeast Comer of said subdivision and the Point of Beginning.
