

ORDINANCE NO. 2613

AN ORDINANCE OF THE CITY OF ENUMCLAW, KING COUNTY, WASHINGTON REVISING THE CORPORATE BOUNDARY OF THE CITY OF ENUMCLAW TO INCLUDE THE UNINCORPORATED PORTIONS OF SE 456TH PROVIDED FOR IN RCW 35A.21.210.

Whereas, the corporate boundary of the City of Enumclaw currently extends along the north margin of the road right-of-way for SE 456th Street from the intersection of 276th Avenue SE to the east line of Lot D, APN3020079089, and

Whereas, S.E. 456th Street as described above is a county road, and

Whereas, a development within the city limits adjacent to the north margin of SE 456th Street is dedicating right-of-way to the city as indicated on Exhibit “A”, attached hereto and incorporated by reference as if set out in full, and

Whereas, with the addition of the right-of-way dedicated to the city that is within the city limits, SE 456th road right-of-way will be partially in the city and partially in the county, and

Whereas, it is in the city and the county’s best interest to have SE 456th road right-of-way wholly within the city’s jurisdiction so that the city may make road improvements under city standards and provide local services to its residents including the maintenance and operation of the public right-of-way, and

Whereas, RCW 35A.21.210 authorizes “the governing bodies of a county and any code city located therein may by agreement revise any part of the corporate boundary of the city which coincides with the centerline, edge, or any portion of a public street, road or highway right-of-way by substituting therefore a right-of-way line of the same public

street, road or highway so as fully to include or fully to exclude that segment of the public street, road or highway from the corporate limits of the city”, and

Whereas, revision of the corporate boundary of a city is effective upon approval by the city council and the county legislative authority as provided for in RCW 35A.21.210.

NOW THEREFORE, THE CITY COUNCIL FOR THE CITY OF ENUMCLAW, KING COUNTY, WASHINGTON DOES HEREBY ORDAIN AS FOLLOWS:

Section 1: The revision of the corporate boundary of the City of Enumclaw to fully include the right-of-way for SE 456th Street as set forth in Exhibit A is hereby approved.

Section 2: If any provision of this ordinance and/or Exhibit “A” attached hereto is determined to be invalid or unenforceable for any reason, the remaining provisions of this ordinance and/or the attached Exhibit “A” shall remain in force and affect.
