Map of Washington State Legislative Districts




Percentage Uninsured by Legislative District, 2012


Percentage Uninsured by Legislative District, 2013


Percentage Uninsured by Legislative District, 2014


Percentage Uninsured by Legislative District, 2015


Percentage Uninsured: Legislative District 1, 2012-15


Percentage Uninsured: Legislative District 2, 2012-15


Percentage Uninsured: Legislative District 3, 2012-15


Percentage Uninsured: Legislative District 4, 2012-15


Percentage Uninsured: Legislative District 5, 2012-15


Percentage Uninsured: Legislative District 6, 2012-15


Percentage Uninsured: Legislative District 7, 2012-15


Percentage Uninsured: Legislative District 8, 2012-15


Percentage Uninsured: Legislative District 9, 2012-15


Percentage Uninsured: Legislative District 10, 2012-15






Percentage Uninsured: Legislative District 13, 2012-15












Percentage Uninsured: Legislative District 19, 2012-15






Percentage Uninsured: Legislative District 22, 2012-15








Percentage Uninsured: Legislative District 26, 2012-15


















Percentage Uninsured: Legislative District 35, 2012-15


Percentage Uninsured: Legislative District 36, 2012-15


















Percentage Uninsured: Legislative District 45, 2012-15







Data Sources and Notes

The original data source for this document is the U.S. Census Bureau's American Community Survey (ACS) 1-year Public Use Microdata Sample (PUMS) file. The designation of Legislative Districts of the ACS records was performed using a crosswalk between Legislative Districts and Public Use Microdata Areas (PUMA) that are available in the ACS files. The crosswalk was obtained from the Missouri Census Data Center's Geographic Correspondence Engine (<http://mcdc.missouri.edu/websas/geocorr12.html>).

In working with the ACS data, OFM analysts uncovered a significant increase of undercount of Medicaid enrollment in the ACS for Washington starting in 2014, the year the Patient Protection and Affordable Care Act (ACA) first rolled out Medicaid expansion program. An adjustment was made to the 2014 and 2015 ACS 1-year PUMS weights to account for the undercount of Medicaid.
