## GRAPHIC DESIGNER 1 Abolished Effective July 1, 2007

<u>Definition</u>: Designs and produces a variety of graphic projects including printed publications, video, slideshows, three-dimensional exhibits, and illustrative materials, using tools such as computers and their associated peripherals.

<u>Distinguishing Characteristics</u>: This is the fully competent working level within the series. Positions are responsible for developing and designing a variety of illustrative materials in conjunction with a client. Positions work independently and provide recommendations and advice to clients on practical applications of graphic design, selection of paper stock, type-style, ink colors, photography, and in determining the most appropriate methods and techniques of designing and producing illustrative materials and publications targeted toward a specific audience.

Note: For the purposes of this specification, the term illustrative means to make clear or more easily understood through the use of drawings, charts, or other materials.

## Typical Work

Designs and produces graphic projects such as publications, logos, advertisements, maps, Internet materials, drawings, displays, video, slideshows, and other illustrative materials;

Illustrates assigned subject matter in a variety of media including computer graphics and traditional methods such as pen and ink, pencil, painting, etc.;

Explains to department staff the effective use of graphic designs and production costs; offers ideas, suggestions and information on techniques, content, and as it pertains to getting communications reproduced;

Designs informational materials, taking into account intended use, audience, cost estimates and distribution and the project's and department's goals and objectives;

Produces complex, computer-generated multi-page photomechanical art or separations for black and white, and color reproduction, using graphic design software for page layout, illustration, and photo manipulation (<u>not word processing software</u>);

Accomplishes typographic compositions, conversions and manipulations of photographs and illustrations, using a variety of reprographic techniques, computer software, and materials;

Provides detailed written instructions to lithographers for a variety of reproduction elements, including type specifications, paperstocks, ink, folding, scoring, embossing, engraving and binding techniques;

Ensures compliance with agency design standards, logo usage and Americans with Disabilities Act requirements;

Goes on site and takes photographs for projects;

Performs other work as required.

## Knowledge and Abilities

Knowledge of: methods and techniques of graphic design; effective application of materials and media; graphic lab equipment.

Ability to: design and produce a variety of illustrative materials; design and produce electronic presentations; lay out and produce printed materials.

## Minimum Qualifications

A Bachelor's degree in graphic design or closely allied field and one year of professional graphic design experience.

<u>OR</u>

Two years of design school or college-level design training <u>and</u> two years of professional experience in graphic design.

OR

Two years as a Graphic Assistant or equivalent in State service.

Additional professional graphic design experience is substitutable for education on the basis of one year of experience for two years of education.
