#### PARK RANGER 5

# Abolished Initially Effective January 13, 2006 Abolished Final Effective February 10, 2006

<u>Definition:</u> Manages a Class 5 State park or park area developing, controlling and accomplishing all program activities for parks in non-contiguous locations.

<u>Distinguishing</u> <u>Characteristics</u>: Allocation to this level is determined by the assignment of points by the Park Management Position Allocation System.

## Typical Work

Identifies, plans and schedules all park functions and activities for the staff on an annual basis which is updated quarterly and as required to fulfill the operational function of the park;

Directs a program of construction and maintenance of park structures, camp sites, water and sanitary systems, recreational, camping, picnicking, interpretation and other park facilities;

Collects and accounts for charges; assists in the preparation of the park's maintenance and operation budget including manpower and equipment for inclusion in the region budget; manages the maintenance and operating funds allocated to the park;

Disseminates information to the public; establishes and maintains cooperative relations with the general public, contractors and with officials of other interested public jurisdictions;

Protects park properties; exercises commissioned police powers;

Supervises Park Rangers, Park Aides and other employees; trains park personnel, evaluates their performance and recommends appropriate action;

Oversees activities of concessionaires to ensure compliance with concession agreements and park rules;

Represents and acts for Washington State Parks at designated meetings, gatherings, and conferences; may act as Assistant Regional Supervisor; by direction, gives speeches where required;

Receives and adjusts complaints; writes letters; assists in the gathering of information for park usage and trends;

Performs other work as required.

## Knowledge and Abilities

Knowledge of: the philosophy of recreation; problems in protecting, maintaining and improving a State Park unit; the purposes, organization, policies and rules of the State Parks and Recreation Commission; method used in receiving, accurately recording and safeguarding money; principles of effective supervision.

Ability to: perform a variety of skilled maintenance tasks; keep records, write reports; favorably represent the Commission in day-to-day contacts with the public.

# Minimum Qualifications

A Bachelor's degree in park management, outdoor recreation, conservation, forestry recreation, environmental resources, or other closely related fields <u>and</u> two years of experience as a Park Ranger 3 or equivalent in former Ranger/Manager class series within Washington State service.

OR

Three years of experience as a Park Ranger 3 or equivalent in former Ranger/Manager class series within Washington State parks.

OR

One year of experience as a Park Ranger 4 or equivalent in former Ranger/Manager class series within Washington State service.

An unrestricted (other than corrective lenses) driver's license.

NOTE: Employees are required to be fully commissioned law enforcement officers.

 ${\rm \underline{NOTE}}$ : The Washington State Parks and Recreation Commission will designate the need for a Commercial Driver's License (CDL) with specific endorsements. Candidates selected for CDL positions will be tested for use of controlled substance and alcohol misuse as required by the 1991 Federal Omnibus Transportation Employee Testing Act.
